



Article 1: Purpose of the Agreement

- kunwar Shekhar Vijendra Ayurved Medical College & Research Center Shobhit Univershity Gangoh Saharanpur Uttar Pradesh, (KSVAMC & RC) is a reputed institute of higher learning in the country, serving the cause of National Development by offering tertiary education and conducting basic and applied research in various disciplines.
- II. Dev Rishi Hospital & Research Center, Located at Sarsawa Road, Nakur, Saharanpur U.P, equipped with ultra-modern state-of-the-art facilities and is implementing latest treatment techniques in the service of human health care.
- III. Collaboration for teaching of relevant portions of the courses and for conducting structured residency (Internship) / field training/ attachment is essential for many Departments of KSVAMC & RC where course work are related to Medical Sciences and for this purpose a MoU with an established institution like DEV RISHI is envisioned.

Article 2: Implementation of the MoU

- I. The work related to the academic instructions required for various Medical Science related courses will be conducted in relevant Departments of KSVAMC&RC / Dev Rishi Hospital & Research Center. The payment to the instructors will be made on lecture basis as per Rules of the KSVAMC & RC in this regard, prevailing at that time, as modified from time to time.
- II. Dev Rishi Hospital & Research Center agrees to extend its facilities for conducting the practical exams as well as residency I field training / workshops/ attachments etc. free of cost.

Article 3: Restrictions and Limitations

- This agreement is not to be construed as contract in law, creating legal relationship between the two
 institutions. Instead, it is formulated in the interest of generating human resource in the field of Medical
 Sciences to facilitate and develop mutually beneficial synergistic academic activity.
- II. In the spirit of this agreement, each institution is considered as principle. Neither institution is authorized or empowered to act as agent for the others for any purpose or shall enter on behalf of the others into any contract or representation on any matter. None of the two institutions shall be bound by the acts or conduct of the other.
