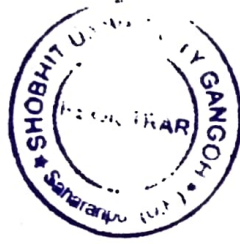

5. Commitment to a Safe Campus: Participants pledged to uphold the principles of mutual respect and contribute to a safe and welcoming environment.



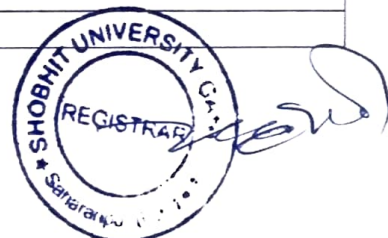

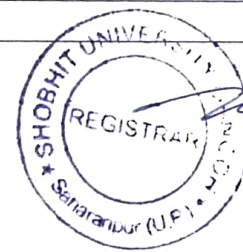
